THE SUN WILL RISE

I was given the name Mook'aam Ikwe, which translates to Sunrise Woman, but I am known as Nicole. One of my Indigenous elders Patricia Danard gifted me this name which I wear with grace and hold in high honor. I was born in the fall when the leaves began to turn their vibrant colors on Haudenosaunee land. I am connected to the land's boreal forests, waterfalls, rigid escarpment and Great Lakes. The vibration of the land gives me a sense of security which I did not find when I ventured overseas in my younger years. Although I miss the lands of my ancestral lands, I am now a guest on Treaty 7 among the Rocky Mountains and the Bow River. The elegant flow of the river which waves hold ancient stories within its ripples. I am grateful to the peoples of the land to welcome me and give me my Blackfoot traditional name Beak Saki which was gifted to me after seen in a dream. I am known as Magpie Woman the magpie is an intelligent and diligent bird.

My Indigenous ancestry includes both the Algonquin and Huron- Wendat Nations. My healing journey began when I returned to Turtle Island in late 2015. At this time, I started to reconnect with traditional ways of knowing, embraced my Indigenous identity, and continued my journey of discovery.

My spiritual journey has been a twisted road which has ultimately been a source and spectrum of emotions allowing me to heal through grounding, and senses of hope and finally peace. I have found growth and a deepened understanding of myself as I have strengthened my connection to my current spiritual community. I am a firm believer that the Creator, through my own curiosities guided me to my final spiritual destination.

One may develop resilience as I found through intergenerational traumas such as addictions and various forms of abuse, including emotional, mental, physical and spiritual. My life story has been touched by varying degrees by all of these areas, however I am committed to turning these negative experiences into positive learning lessons. I want to empower others by sharing strength and helping others in their journey to building resiliency and finding peace. I have reconnected to my culture by joining ceremonies and traditional sweat lodging, sharing circles and smudging, and leading circles of learning. My family has been instrumental in sharing ways of knowing through storytelling. Charles Johnson, my 2^{nd} great grandfather left Quebec in the mid 1800's to settle in the bush in Hastings County, Ontario.

I began to understand my family through my personal research with verified bloodlines of past generations; and their secrets and their deeply held stories of survival.

My own personal journey has been the foundational block in developing compassion and empathy as I engage clients. I carry a unique perspective and understanding for those who may face complex challenges while maintaining professional boundaries and confidentiality. Personal experiences have molded my approach when supporting and working with others in a professional manner. My mission is to help others move forward in a proactive manner to overcome their barriers. I have been motivated to give back to both the Indigenous and non-Indigenous communities. In supporting those in need in my community I have utilized system navigations including; agency advocacy, translating in provincial court, connecting to resources while encouraging independence.

I volunteer yearly with the ALS Society of Alberta *Betty's Run*. I have found that giving to others offers a rewarding reflective life gift to the giver. My own mother was an ALS warrior which took her young life at the age of 55, after a short battle with this devastating disease. I was my mother's caregiver since the age of 11 years old. Volunteering at the ALS annual events is my way of doing my part in helping support research efforts and other services the association offers their clients.

I am also a volunteer mentor with the 6 Nations Rivers to Success initiative. As I grew up a short distance from the reserve, I have warm memories of the Mohawks traditions and culture. As an expression of gratitude for this relation and the sense of belonging it has provided me, I now volunteer as a way of paying forward. This initiative reaches Indigenous peoples across Turtle Island from all walks of life that want to enrich their educational experiences. This venue has given me the opportunity to provide counselling and advocacy and a way to connect others to relevant resources while inspiring myself to social work. I am now pursuing my education as a student through Northern Lakes College social work diploma program offered online through distance learning. This financial aid would provide the means necessary for me to be able to accomplish my goal of becoming a registered social worker.

I once heard when you are able to speak of past traumas with even breathe, it is a sign of movement towards a deeper healing. I have noted in my personal healing this to be true. In honoring my own journey and my gratitude to the Creator, I actively choose to support others on their journey and hope for no recognition other than from the Creator.
