My whole world changed and life became so difficult. I have to take antibiotics for the rest of my life, I also have to use an apparatus twice a day to get excess mucus out of my lungs. My new reality is focused on staying safe and conserving energy. The added stress of covid and my lung disease has complicated my life with anxiety and depression so my priorities have changed and I learned to focus on health and a balanced lifestyle. With all this being said my disease has become a real growing experience for me. In many ways I am stronger for this challenge in my life. I am looking forward to my future.

I had to be realistic and find a career in medicine where I wouldn't be exposed to airborne illnesses. I also had to find a career that was a less intensive program. I decided to pursue a career as a Vet Technician which is a 2 year college program. A Vet Tech is a veterinary nurse who works alongside a Vet. I love animals and helping people with their pets. I volunteer at a vet clinic and I love getting to help animals. I belong to Elderdogs which is a volunteer group that cares for seniors who need help with their dog's grooming, administering medications and dog walking. I love helping out seniors so they can keep their dogs which is instrumental for their well being. I have been pet and house sitting as well as dog walking for years. I love being able to hang out with various animals and learning how to take care of them. I have animal sat for horses, pigs, chickens, ducks, guinea pigs, bunnies, fishes, cats and dogs. All my neighbors know me and know they can depend on me for pet sitting.

I would like to mention why receiving this scholarship is so important to me. This lung disease has made it challenging over the past couple of years with covid being around because I have had to be extra careful not to catch covid. I did all of my grade 11 online and had to limit my in person attendance in grade 12 and I had to reduce my work hours to limit my covid exposure. This has slowed down my income for the past 2 years. This is why I am hoping to get this scholarship as I haven't been able to work as much as I wanted to. My parents had me at 40 years old and my mom has been a stay at home mom since I was born. She is now recovering from a stroke. My dad wants to retire next year and so they will not be able to help pay my tuition. I take pride in myself being independent and would appreciate any financial help.

**Date of Respiratory Consult**

14 April 2020

Raven was seen today for followup and discussion of her CT results.

**Diagnoses**

1. Bronchiectasis, right lower lobe, most likely post-infective.
2. Reactive airways.

**History**

Raven and her mom report there has been no change in her symptoms. She continues to have a mild intermittent cough and mainly complains of fatigue and low exercise tolerance. She seems to benefit from the Breo even though her methacholine challenge was negative. She definitely notices a change to the worse in her symptoms when she stops the Breo.

**Current Medications**

Breo Ellipta 200/25 mcg 1 dose daily.

**Allergies**

No known.

**Physical Examination**

This was unchanged from before. She is a small and thin girl who had no congestion or cough in clinic and was breathing comfortably. There were crackles over the left lower lung zone. She has no fingernail clubbing.

**Investigations**

The bronchoscopy revealed pus coming out of the right lower lobe. This grew hemophilus influenza beta lactam positive, sensitive to Clavulin. Results for a fungal culture and atypical mycobacterial culture are still pending. Initial report after one week of culture was negative for both.

**Recommendations**

Long-term therapy for bronchiectasis was initiated today. Due to her haemophilus culture, she will initially complete 1 week of a full dose Clavulin. This will then be followed by azithromycin 500 mg daily 3 times a week. In addition she was trained in the use of Acapella which she will do twice a day to improve mucus clearance from the affected area.

In two months.
